 - i. Open Public Hearing:

Bromley Hall, Hall Contracting, explained the business and how they will be using Suite 1. Suite 2 will be vacant and any tenant coming in will go through the permitting process separately. There will be very little on-site sales, and the back area will be used for maintenance and minor cleaning of the hospital equipment. Large delivery vehicles will be very rare. The business is nationwide, and currently is located in Marquette, with five employees.
