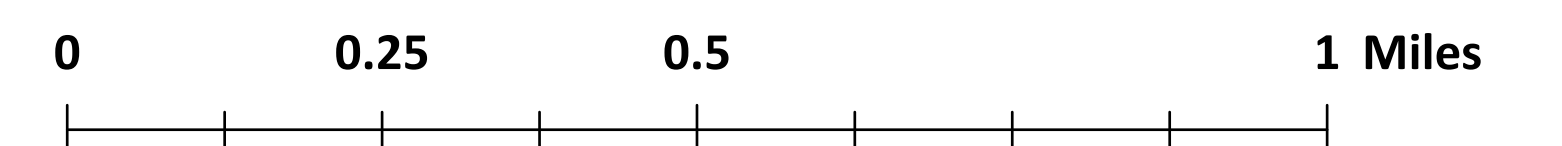
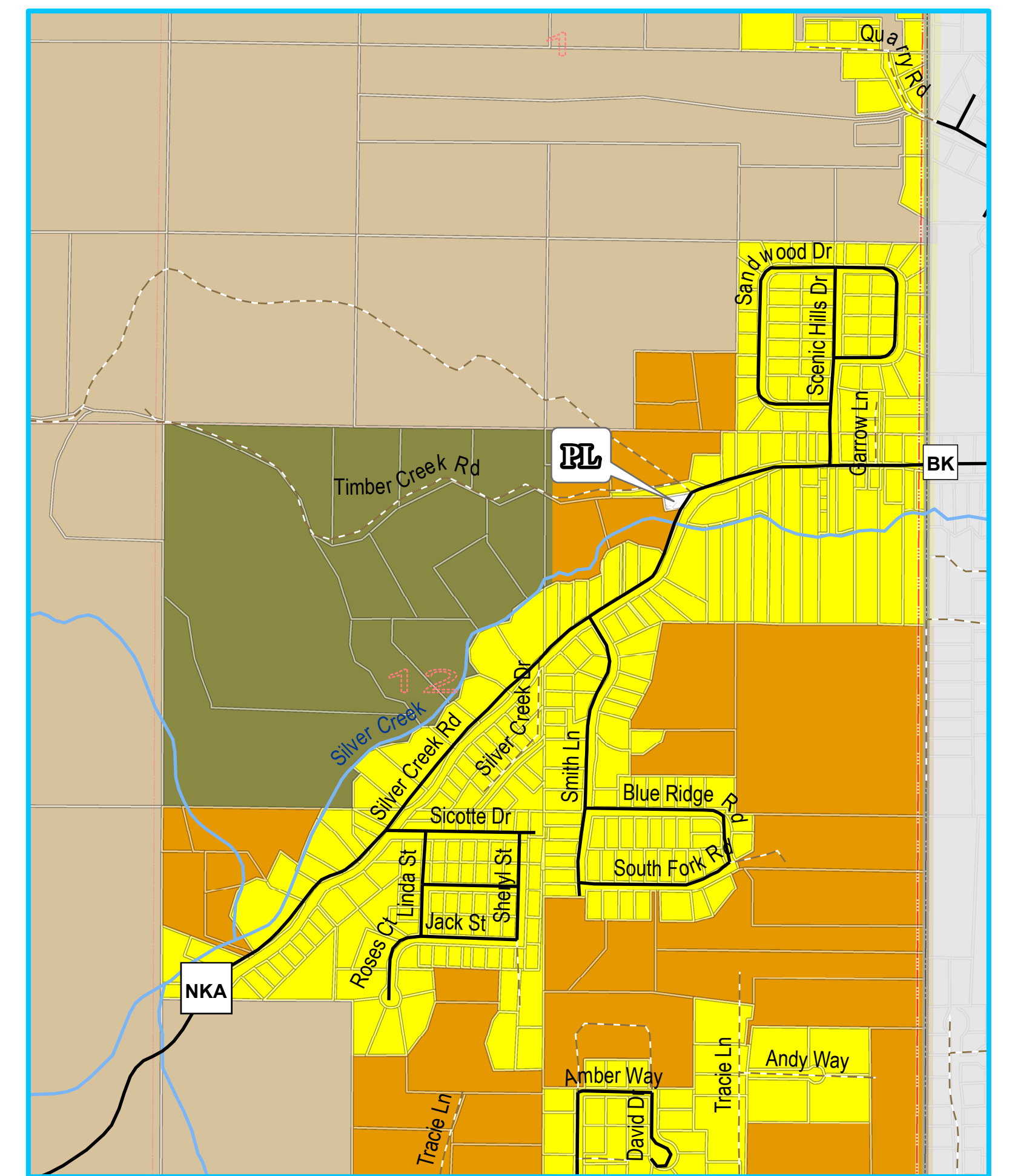


# Official Zoning Map

The Highway Overlay Zone is defined as: All lots and parcels that abut the right-of-way of State Highway M-553 and the right-of-way of County Road 480 and such other lands that front on intersecting streets within three hundred fifty (350) feet of the State Highway M-553 or the County Road 480 right-of-way within Sands Township
