Kallio seconded, to increase the General Fund budgeted expenses in the Clerk line item by \$900, for a total of \$40,466 in expenses, to increase the Legislative expenses by \$300 for a total of \$20,802, and to increase the expenses in the Public Works line item by \$40, for a total of \$9,472, and to take that \$1,240 total from the Attorney line item, leaving \$11,360 in budgeted expenses.
